Minutes of 2024 Annual Meetings

Eastminster Presbyterian Church, East Lansing, MI Annual Meeting of the Congregation/Corporation January 28, 2024

Rev. Kristin Stroble, Moderator

The annual meeting of the congregation of Eastminster Presbyterian Church, East Lansing, Michigan, was held on Sunday, January 28, 2024, at 10:54 A.M., immediately following worship service, in the church sanctuary. The moderator, Rev. Kristin Stroble, called the meeting to order, declared there was a quorum and opened with prayer.

Linda Hardenbergh moved that this meeting constitute the annual meeting of the corporation of Eastminster Presbyterian Church for 2024, and that its proceedings and conclusions are the actions of the corporation. The motion was supported and was carried.

Minutes of the three congregational meetings in 2023 were provided by email and at the meeting, as part of the 2023 Annual Report. All had been previously approved by the session. Sam O'Neill moved that the congregation approve the minutes of the three meetings. The motion was seconded and carried

Susan Smalley presented the nominating committee's report and placed in nomination its slate of at-large members: Rick Johnston, Irv Nichols, Mary Harvey and Elaine Cable. She also placed in nomination Patsy King for session, as an elder in the class of 2025. Rev. Stroble asked for additional nominations from the floor; there were none. There was a motion to close nominations and cast a unanimous ballot for these at-large nominees. The motion was seconded and was carried.

Treasurer Bob Kleine presented the financial reports and budget. 2023 operating income of \$314,991 exceeded budgeted income and expenses of \$333,946 were lower than budgeted expenses. Additional income came from transfers of \$10,000 from reserves and \$8,668.10 from endowment income. Reserves at year-end were \$102,097 and endowment funds were \$865,731. Expenses continue to exceed revenue, due mostly to inflation and member deaths. Work is under way to develop a five-year financial plan to deal with these issues

The 2024 budget was presented. There were questions and comments about the annual operating deficit, purpose of the endowment fund, membership of infrastructure and endowment committees, income from groups using the building, changes in music during worship services, investments in sanctuary AV equipment and endowment investment management fees/returns. There was a motion to receive the treasurer's report. The motion was seconded and carried.

Mary Lou Clifton reviewed the pastor's terms of call for 2024. There were questions and comments about the pastor's discretionary fund, auto allowance, and expenses. There was a motion to approve the pastor's terms of call. It was seconded and carried. Elder Clifton also reminded the congregation that Rev. Stroble would be taking a three-month sabbatical in 2025.

From Your Pastor

Reflection and Looking Ahead:

This is our first joint Program and Congregational/Corporation Meeting. The Session made the decision to move to one congregational meeting so that our financial reports and program reports tell the story together of our ministry and mission here at Eastminster. Since we just had a program report in August of 2024 this report will reflect half the program year and next year we will be on a

regular once a year schedule.

This Fall was challenging with the sudden building repairs that forced us to temporarily vacate our building. I am so grateful for the generosity of this congregation in stepping up to help pay for this unexpected bill. I am also grateful we had the opportunity to worship with our siblings in other places and for their hospitality.

Even in the midst of that challenge we still had our annual kids lead worship Sunday, we kept serving at Advent House, we cared for each other and were back in our building for Advent and Christmas. You will read more about our activities in this report.

What's next?

I am grateful for the opportunity to take a sabbatical this year. A sabbatical is an extended paid time off to seek God and to engage in activities that provide rest, refreshment, and renewal. During a sabbatical leave there is no contact between the congregation or its members and the pastor. It is a mutual time of rest and renewal. The session and myself have been preparing for this time apart. I will be on sabbatical from April 28-July 28, 2025. Our own, Rev. Dr. Jeff O'Neill will be covering in my absence and we will be communicating more details as the year progresses.

A report of a leaking toilet led to the discovery of a rusted soil pipe and ventilation duct. Work couldn't begin until asbestos in the boiler room was removed. The church building closed from Oct. 7 until Nov. 1. Many members and participants in the church community donated to help mitigate the costs.

Frank Lloyd Wright Conservancy Tour



One of the year's pleasant surprises was contact from the Frank Lloyd Wright Conservancy. They arranged to tour our building on September 29. Norm Mackay, Sam O'Neill, Bob Nees, Irv Nichols, Cindy Mackay, Robin Bell, Rev. Kristin Stroble and Bridgette Redman hosted the 80 visitors who were extremely interested in our building, designed by the Wright apprentice, Alden Dow. In the weeks leading up to the tour, Eastminster members pored through historical documents and blue-prints, uncovering the history of the building so that they could share stories with the guests when they arrived.

We partnered with the Alden Dow Home & Studio in Midland, who also provided information about our building. We discussed with them a future partnership where they could preserve some of the many historical documents we have housed in our building. There are also discussions for Eastminster to take a guided tour of the Alden Dow home in the summer of 2025.

Unbeknownst to us, that would be the last time worshipping in our sanctuary for several weeks as the church had to unexpectedly close days later because of pipe damage in the boiler room. The committee coordinated with Kristin on alternative places of worship for the next three weeks. We had a Sabbath Sunday with a town hall meeting via Zoom on October 13. Children and youth met at the Heitman home to plan for leading worship in November.

Many of our neighboring churches reached out to us, offering space for us while we were unable to use our building. We celebrated joint services with Presbyterian Church of Okemos and First Presbyterian of Lansing on October 20 and October 27. Kristin preached at the service at First Presbyterian, after which several of us walked across the parking lot to Salt Rock Brewery for their Sunday Brunch.

Advent planning started in September for the Sermon Series: Words for the Beginning. Advent Candle lighters and readers were found for the five services in Advent. The Advent Banner was printed by Kinko's and hung the day before the Hanging of the Greens on December 1. An intergenerational Advent workshop was held December 8. December 15 saw an extended fellowship time, December 18 was a Quiet Advent Service, and December 21 was the Community Christmas Fest.

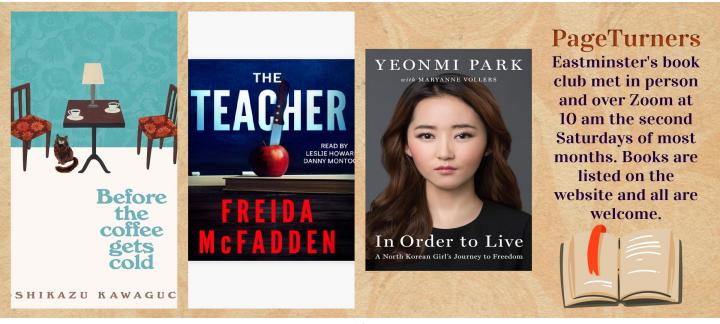

Eastminster Children and Youth are engaged in a number of ways in the life of this congregation. This fall alone they prepared and led two Sunday morning worship services, our youth who went to Massanetta on Sep 8, and our children and youth on November 3 for All Saints. Our youngest friends are engaged each week in their special worship space at the front of the sanctuary with supplies provided by Faith Formation team. They regularly help pack up the welcome kits for refugees, served at Advent House, sent messages of hope to school children displaced by the effects of Hurricane Helene in Western North Carolina, served as acolytes, collect monthly Centsability offering, and participated in CROP Walk. They participated in all church gatherings including Advent workshop and Community Christmas Fest.

Infrastructure

Building and Grounds

The most notable building event was not on our agenda, nor did we anticipate it. The church building was closed from Oct. 7 through the end of that month, without heat or water, due to a rusted soil pipe and ventilation duct. Asbestos in the boiler room was removed and pipes, ducts and insulation were replaced at a total cost of \$51,008. Congregation members and friends provided \$37,320 to offset these unanticipated costs, leaving an unbudgeted \$13,688 to pay. Due to uncertainty about when our building would reopen, the City of East Lansing decided to temporarily move their polling place for the Nov. 5 election. They plan to return next year.

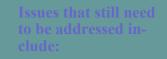
The committee oversaw several repairs and improvements:

- ◆ The building security system and panic buttons, which were not working properly, were tested and are now in working order.
- The elevator battery was replaced. Challenges with our current elevator maintenance company has resulted in efforts to identify a replacement.
 - ◆ Thanks to a generous member donation, we now have a new defibrillator, located in the Narthex.
 - Another generous member donation provided the bench outside the Narthex door.
 - ◆ A hard drive for our building security cameras was installed, and now all staff members plus Mike Jones (our network guru) can access all cameras from their computer and phones.
 - An additional notebook computer was purchased using Memorial funds and is used for worship service AV.
 - We replaced the aging Office Administrator's computer after several months of research. Unexpectedly, a refurbished model arrived 12/30/24 rather than the new one ordered, but
 - we chose to keep it in exchange for a credit on the price.

A member donated money to pur-

chase AED equipment.

- Bulb & Battery Replacement Day was held in November, with a wonderful response from congregation members to help.
- Norm Mackay reformed a building team to regularly monitor the building for any needed maintenance and to undertake some regular maintenance tasks. Members include Jeff Lapinski, Jeff O'Neill, Emmanuel Yewah, Dave Duryea, Susan Smalley, Jim Artabasy, Bob Nees and Sam O'Neill.
- ◆ The garden area was improved with a grounds clean-up by Vera Landscaping and tree pruning by Top-Notch Tree Trimming. As the operating budget did not provide funds for this work, the Memorial Committee agreed to pay the \$3,226 cost.



- ◆ Dependable WiFi connections for webcasting continues to be a challenge.
- ♦ Additional pruning is needed on trees near the building.
- ◆ The grounds appear to be mole-infested and in need of treatment.

Financials

Eastminster's financial review was conducted on 6/19/24 by staff and members from Okemos Presbyterian and First Presbyterian of Holt, and we have acted on many of the recommendations. Budget review is an important part of each monthly Infrastructure meeting. The committee helped conduct our stewardship campaign and develop a proposed operating budget.

A long-range financial planning task force was appointed, chaired by Bob Kleine, with Josh Vermaas, Norm Mackay and Sam O'Neill. They are receiving assistance from the Presbyterian Foundation, to whom we provided financial and property information. When adjusted for inflation, Eastminster's spending has dropped about 20% during the past decade.

Cost of health care promises to be a challenge in future budgets. Policy changes by the Board of Pensions benefited our 2025 budget but will mean large cost increases starting in 2026. We spent considerable time reviewing potential options this year, but the closing of one statewide plan will limit future options. We did recommend adding church-funded health care flex plans for church employees.

Financial Reports

2024 Financial Overview

The 2024 budget turned out better than expected as income exceeded projections for the sixth consecutive year and expenditures were less than projected.

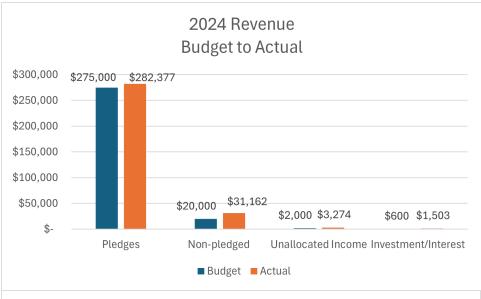
Ongoing income for 2024 was \$320,744, which was \$21,144 more than estimated. Member giving exceeded the estimate by \$7,376 and plate revenue by \$11,161. This was largely due to several members giving more than pledged. The church also received significant contributions from several individuals who did not pledge, which is counted as non-pledged giving.

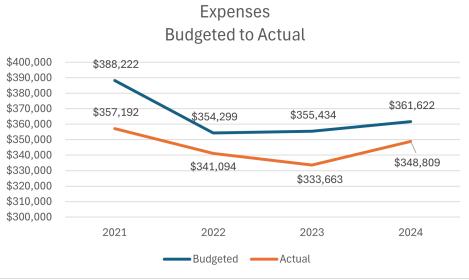
Total income was \$348,809, which includes a transfer of \$14,032 from reserves and \$14,032 from endowment income.

The adopted 2024 budget was \$363,336. Actual expenses were \$348,809, which was \$14,527 less than budgeted. The major differences were \$6,387 not spent for Building and Grounds (mainly snow removal, gas service and structural maintenance and repair), \$1,502 not spent by Worship and Music, \$1,307 not spent by the Mission Committee.

Expenditures for 2024 were 4.6% more than 2023 expenditures.

There was an unexpected expenditure in 2024, the repairs in the boiler room. The total expense was \$51,008, of which \$37,320 was covered by contributions and the remainder of





\$13,688 by a transfer from endowment income.

The ending balance for 2024 was a negative \$28,065, which as noted above, was covered by a transfer from endowment income and reserves. The budget shortfall was originally estimated at \$63,036.

As noted, this was a much better outcome than expected, but we continue to face budget challenges in the future. We are projecting a budget shortfall of \$40,954 for the 2025 budget. Overall, the church's finances are strong. Our reserves at the end of 2024 were \$113,379 and our endowment funds were \$941,746.

Our expenditures continue to exceed ongoing revenue, due in large part to declining membership and inflation, but there is a strong commitment to develop a five-year plan that will reduce our reliance on reserves and endowment income. We are receiving planning assistance from the Presbyterian Foundation.

However, it will not be easy as we have already made substantial cuts in the budget in the past few years. Personnel accounts for 65% of the budget and building and grounds for almost 19%, leaving little room for significant budget cuts. Also, we have reduced our budget by about 20%, adjusted for inflation, over the past five years.

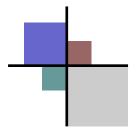

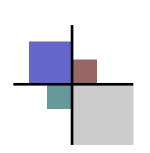

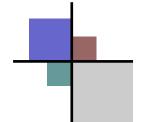

Endowment Report

Eastminster Presbyterian Church began the year with an endowment fund balance of \$885,969 and ended the year with \$942,096. We withdrew 4% of the fund or \$36,166, paid an investment fee of \$8,729 (1%), and had an investment gain of \$100,732, which consisted of \$25,704 in dividends and interest and \$75,028 in capital gains, an increase of 11.4%. Our stock holding increased 18.2% and our bond and cash holdings increased 1.8%.

At the end of 2024, the endowment fund was comprised of 61.92% is stocks and 38.08% in bonds and cash. Our investment policy sets a range of 40%-65% in stocks and 30%-50% for bonds.

The Endowment Income Fund had a year-end balance of \$45,244.88. There were total expenditures of \$10,924 from the fund in 2024. The expenditures were: \$7,500 to Water4life, \$1,000 for special mission, and \$3,424 for security cameras.

The Endowment Committee and Session approved a transfer of \$14,032 from the fund to cover 50% of the budget shortfall. In 2025, we will transfer \$13,200 to pay for the boiler room repairs not paid for by contributions.

In addition to the Endowment Fund the church has a substantial reserve fund. The reserves are held by LPL Financial and managed by BlackRock Investment. We have two accounts. The reserves in the Growth with Income portfolio were valued at \$102,197 at the beginning of the year and ended the year with a balance of \$113,379, an investment gain of \$11,182 or 10.9%. The reserves are comprised of 64% in stocks and 36% in bonds and cash. We also have a trading account as a pass-through for stock donations. The balance at the end of the year was \$983.

In 2024, we cashed in a \$25,000 CD purchased in 2023 and a \$10,000 CD purchased in 2024. We earned \$946 in interest income.

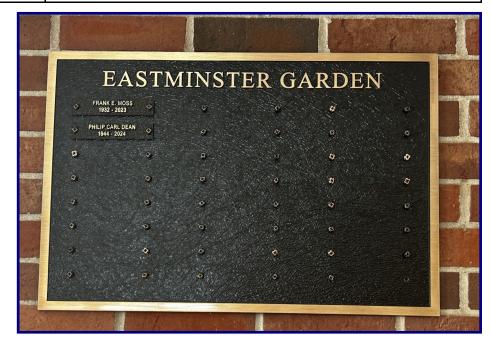
